## MINUTES

Members Present: Doug Lee, Bart Coons, Troy, Justmann, Joe Ludtke, and Mayor Dan Wegener

The Meeting was called to order at 6:00 pm and roll call was taken.

Justmann/Lee motioned to approve the agenda. Motion carried.

Justmann/Lee motioned to approve the minutes from May 28, 2025. Motion carried.

**Public/Citizen Comments:** None

**Review, Discuss, and Possibly Approve Repairs to Storm Sewers on E. Oak Grove St.**

Lee motioned and Justmann seconded to approve repairing storm sewers on E. Oak Grove Street not to exceed \$12,000. Motion carried 2-0. Committee forwards to Finance.

There are several areas that need to be addressed. There is a major plug by Kwik Trip/Main Street. Joe stated that there are cracks and broken areas that need to be fixed before E. Oak Grove St. can be redone. Intercon drilled through a storm sewer main while doing some work for the City of Juneau. Joe stated that they would be paying for the section they damaged.

**Review, Discuss, and Possibly Approve Putting Final Course of Asphalt onto E. Oak Street (from Fair St to Main St) and Miller Street.**

Justmann motioned and Lee seconded to approve ramping the driveways on Miller Street and E. Oak Street (from Fair Street to Main Street) not to exceed \$4000.00. Motion carried 2-0.

Joe discussed that there have been some complaints on the 2-inch gap from the road to the curb on Miller Street and on E. Oak Street. There has been one incident with a resident tripping on the lip and falling. The cost to ramp the lip around Miller and E. Oak Streets would cost about \$12,000. The mayor stated that the City always waits the full year to put the final course on because of settling in the asphalt. If the City puts it on prematurely, we could have bigger issues in our roadways that will need attention later on. The final course of asphalt will go on E. Oak Street from Fair to Depot Streets this year, with the final course for E. Oak Street (from Fair to Main Street) and Miller Street will go on next year. Joe stated that the DPW will paint yellow on all the dangerous areas.

**Superintendent's Report was presented.**

Joe gave update on tree removal on the Wild Goose trail, still cleaning up the parks from the tornado, and issues with the stamped concrete at the Gathering Plaza. Joe and the Mayor will be meeting with the contractor in the morning to discuss repair options.
