Ordinance to Amend City of Juneau Ordinance 13.08.080 - Amount of Sewer Service Charges

The Common Council of the City of Juneau Ordains to Amend as Follows:

13.08.080 Amount of sewer service charges.

FROM:

- A. General Sewer Service—Metered. For all users except commercial/industrial users and significant industrial users, the following charges shall apply:
 - 1. Monthly Service Charge. The monthly service charge recovers portions of operations, maintenance, replacement, and capital costs as shown below:

2. Volume Charge. Each one thousand (1,000) gallons of sewage discharged into the sanitary sewer:

- 3. Credit for water not discharged to the sanitary sewer: See sewer utility operating rules and regulations.
- B. Commercial/Industrial Users.
 - 1. Monthly Service Charge—Same as general sewer service.
 - 2. Volume and Strength Charges. Each one thousand (1,000) gallons of sewage discharged into the sanitary sewer:

The commercial/industrial sewer service charge for volume	\$7.12
BOD per pound (over 250 mg/l)	0.54
SS per pound (over 250 mg/l)	0.40
PHOS per pound (over 6 mg/l)	15.33

TO:

- A. General Sewer Service—Metered. For all users except commercial/industrial users and significant industrial users, shall be periodically established by the Utility Commission and approved by the Common Council and shall be kept in the Clerk's office. The monthly service charge recovers portions of operations, maintenance, replacement, and capital costs
 - 1. Monthly Service Charge. The monthly service charge recovers portions of operations, maintenance, replacement, and capital costs and the monthly service charge shall be periodically established by the Utility Commission, approved by the Common Council, and shall be kept in the Clerk's office.
 - 2. Volume Charge. Each one thousand (1,000) gallons of sewage discharged into the sanitary sewer cost shall be periodically established by the Utility Commission, approved by the Common Council, and shall be kept in the Clerk's office.
 - 3. Credit for water not discharged to the sanitary sewer: See sewer utility operating rules and regulations.
- B. Commercial/Industrial Users.
 - 1. Monthly Service Charge—Same as general sewer service.
 - Volume and Strength Charges. Each one thousand (1,000) gallons of sewage discharged into the sanitary sewer cost shall be periodically established by the Utility Commission, approved by the Common Council, and shall be kept in the Clerk's office.

Section 13.08.080 Sewer Service Charges is hereby amended.
